IRRIGATION RATE SCHEDULES

AVAILABLE

At locations within the limits of the district's territory and outside the corporate limits of a municipal entity. Applicable to customers located on or near the District's line for service to irrigation pumps subject to the established rules and regulations of the District.

TYPE OF SERVICE

Alternating Current (AC), single & 3-phase, 60-cycles, at available secondary voltages.

NO CONTROL - 16, 17, 18

Demand Charge: \$56.00 per calculated horsepower per year

Energy Charge: \$0.13053 all kWh

ANYTIME CONTROL – 19, 20, 21, 22

12.5 HOURS PER DAY - 6 DAYS PER WEEK AND SUNDAY CONTROL

Demand Charge: \$23.50 per calculated horsepower per year

Energy Charge: \$0.08645 for the first 120 kWh x the calculated horsepower
\$0.05626 all excess kWh

EVERY OTHER DAY CONTROL – 28, 29, 30

12.5 HOURS PER DAY – 3 DAYS PER WEEK AND SUNDAY CONTROL

Demand Charge: \$35.75 per calculated horsepower per year

Energy Charge: \$0.09163 for the first 140 kWh x the calculated horsepower
\$0.06035 fall excess kWh

TERMS OF PAYMENT

The demand charge will be divided by 4 and billed on the first of June, July, August and September of each year. The energy will be billed on the first of July, August, September, and October, as well as a final energy billing on December 31 of each year.

June 1: ¼ Demand billing
July 1: ¼ Demand billing + energy used in June
August 1: ¼ Demand billing + energy used in July
September 1: ¼ Demand billing + energy used in August
October 1: energy used in September
December 31: all excess energy used since September

DETERMINATION OF DEMAND CHARGE:

The demand charge is based on calculated horsepower. This calculated horsepower shall be the result of dividing the previous irrigation season's highest recorded kilowatt (KW) demand for each irrigation meter by .83, or kW/.83. This calculated horsepower shall be multiplied by the appropriate demand charge. If there is no demand available from a previous year for any reason, the nameplate horsepower will be used as the default calculated horsepower.

YEARLY RATES: WHEELS ONLY – 40, 41, 42, 43

Monthly Energy Charge	\$0.1938	All kWh

MAXIMUM HORSEPOWER:

The Wheels Only rate schedule shall apply to irrigation wheels only service with the total billable horsepower not to exceed 15 horsepower or 20KW demand. (Total billable horsepower shall be a total of the tower horsepower divided by 2 plus all end gun nameplate horsepower.) The total customer charge shall be billed on June 1 of each year and kWh energy billed along with other irrigation rate schedules.

YEARLY RATES: STANDBY IRRIGATION SERVICE – 27

Annual Facilities Charge	\$338.00 OR \$14.25 per calculated horsepower, whichever is greater

This rate is for irrigation services not used after the original contract has expired for irrigation service in a calendar year. It shall be billed on June 1 of each year and include a standby charge of \$337.00 or \$14.25 per calculated horsepower (last known calendar horsepower), whichever is greater.

MINIMUM YEARLY CHARGE

The minimum yearly charge under the above rate schedule shall be the facilities charge. The minimum yearly charge if the system is not used is not refundable.

LINE EXTENSION / AID IN CONSTRUCTION POLICY

See included Retail Rate Terms and Conditions page. Additionally, irrigation systems that are constructed under this policy will remain on the same rate schedule that was used to estimate the project for the duration of the recovery period or pay the additional estimated construction costs that are applicable before the rate schedule will be changed.
